
Practices

- 3. Simplify and streamline paperwork
- 4. Be transparent and responsive
- 5. Solicit and act on feedback
- 6. Offer support beyond the check


Nonprofit Feedback Survey Findings

Recognize the racial, economic, and political inequities in which they operate.


Remain open to continuous learning and embrace opportunities for growth.

- 3. Create **opportunities for relationship-building** between funders and nonprofits
- 4. Make decisions and engage with nonprofit from a position that sees them as **community experts and equal partners**
